A Note from the Cottontown Board

Happy fall! Thanks to everyone who hosted a "porch party" over the summer (Dangerfields and the Spaniels) and to everyone who either helped plan (Renee Johnson, Carol Jennings, Rusty Sox and Ginger Thrift) or attended our celebration of National Night Out!

Your Board is closely watching any movement on the property at Scott & Sumter St. and staying in close communication with city staff. Since the last newsletter, the mayor has joined us in two meetings with the developer. While they continue to refuse to answer our questions and still don't seem to be working with the VA nor the Columbia Housing Authority, we believe they are making plans to build a multi-family development that would be permitted with existing zoning (CAC2 & MU2). It is anticipated that we will need neighborhood support to steer this project as it proceeds through Planning, DDRC, and possibly BoZA. Please watch Facebook for information.


